(WHEREAS by Letters Patent approved
(
(the 4th day of December, 1974, the

(City of Nanaimo was incorporated
(
(as and from the 1st day of January,
1975, under the provisions of the Municipal Act being Chapter
255 of the Revised Statutes of British Columbia, 1960:

AND WHEREAS it is deemed expedient to amend the procedures that were established concerning the method of electing council in the said Letters Patent by the issue of supplementary Letters Patent;

NOW KNOW YE THAT by these presents We do order and proclaim that the Letters Patent issued on the 4th day of December, 1974 that provided for the re-incorporation of the City of Nanaimo be amended as follows:

1. By adding the following words to paragraph 4 after the word "election" in the second line: "and at each subsequent election," so that the paragraph reads as follows:

"4. For the purpose of the first election, and at each subsequent election, the municipality shall be divided into zones and separate lists of electors shall be prepared as follows:

Zone 1: that area of the municipality lying within Electoral Areas A and C of the Regional District of Nanaimo, and known as Chase River, Cinnabar and including the industrial areas in the Cedar district, more particularly described in Appendix 'A' hereto;

Zone 2: that area of the municipality lying within Electoral Area B of the Regional District of Nanaimo and known as Harewood, more particularly described in Appendix 'B' hereto;

Zone 3: that area of the municipality comprising
The Corporation of the City of Nanaimo
as incorporated under former Letters
Patent (B.C. Gazette dated March 31, 1960);

Zone 4: that area of the municipality lying
within Electoral Area D of the Regional
District of Nanaimo and known as
Northfield and East Wellington, more
particularly described in Appendix 'C'
hereto;

Zone 5: that area of the municipality lying
within Electoral Area E of the
Regional District of Nanaimo and
known as Departure Bay, more particu-
larly described in Appendix 'D' hereto;

Zone 6: that area of the municipality lying
within Electoral Areas F and G of the
Regional District of Nanaimo and known
as North Wellington, more particularly
described in Appendix 'E' hereto:

2. By the deletion of paragraph (6a) in its entirety
and by the substitution of the following;

"(6a) At the regular annual election to be held
in the year 1976, and biennially thereafter,
provision shall be made for the election of a
Mayor and eight (8) Aldermen as follows, each
to serve a term of two years:

- (1) the election of a Mayor by the electors of the municipality at large who shall hold office on and from the date of the first meeting of Council in 1977 until noon of the first Monday after the first day of December, 1978, or until his successor takes office, and thereafter the provisions of the Municipal Act apply;

- (2) the election by the electors of Zone 1 of the municipality as described in paragraph 4 hereof of one Alderman who shall be resident of the said zone and shall be nominated by two electors of the zone and who shall hold office on and from the date of the first meeting of Council in 1977 until noon of the first Monday after the first day of December, 1978, or until a sufficient number of Aldermen have been sworn in to make up a quorum, and thereafter the provisions of the Municipal Act apply;

- (3) the election by the electors of Zone 2 of the municipality as described in paragraph 4 hereof of one Alderman, who shall be a resident of the said zone and shall be nominated by two electors of the zone who shall hold office on and from the date of the first meeting of Council in 1977 until noon of the first Monday after the first

day of December, 1978, or until a sufficient number of Aldermen have been sworn in to make up a quorum, and thereafter the provisions of the Municipal Act apply;

(4) the election by the electors of Zone 3 of the municipality as described in paragraph 4 hereof of three Aldermen each of whom shall be a resident of the said zone and shall be nominated by two electors of the zone, each of whom shall hold office on and from the date of the first meeting of Council in 1977 until noon of the first Monday of the first day of December, 1978, or until a sufficient number of Aldermen have been sworn in to make up a quorum, and thereafter the provisions of the Municipal Act apply;

(5) the election by the electors of Zone 4 of the municipality as described in paragraph 4 hereof of one Alderman who shall be a resident of the said zone and shall be nominated by two electors of the zone who shall hold office on and from the date of the first meeting of Council in 1977 until noon of the first Monday after the first day of December, 1978, or until a sufficient number of Aldermen have been sworn in to make up a quorum, and thereafter the provisions of the Municipal Act apply;

(6) the election by the electors of Zone 5 of the municipality as described in paragraph 4 hereof of one Alderman who shall be a resident of the said zone and shall be nominated by two electors of the zone, who shall hold office on and from the date of the first meeting of Council in January, 1977 until noon of the first Monday after the first day of December, 1978, or until a sufficient number of Aldermen have been sworn in to make up a quorum, and thereafter the provisions of the Municipal Act apply;

(7) the election by the electors of Zone 6 of the municipality as described in paragraph 4 hereof of one Alderman who shall be a resident of the said zone and shall be nominated by two electors of the zone, who shall hold office on and from the date of the first meeting of Council in 1977 until noon of the first Monday after the first day of December, 1978 or until a sufficient number of Aldermen have been sworn in to make up a quorum, and thereafter the provisions of the Municipal Act apply.

3. By adding the following as paragraph (6b):

"(6b) (1) on or before the 1st day of January, Directors to represent the municipality on the Regional Board of the Regional District of Nanaimo shall be appointed annually, by resolution of the Council, and shall hold

office until the first Monday following
December 1 or until the appointment of
a successor, whichever is later;


- (2) notwithstanding subsection (1), the term
of office for each of the present Directors
shall be completed and an appointment by
resolution of the Council shall not be
made until that term has expired or the
office otherwise becomes vacant.

AND THAT the Letters Patent of the City of Nanaimo be
deemed to be amended accordingly.
